**Proposal by the Board of Directors of Ferronordic Machines AB to the annual general meeting 2016 regarding allocation of the profits available for distribution by the meeting**

Distributable profits available for distribution by the meeting amount to SEK 391,657,644.

Having regard to the current economic situation in Russia and the uncertain effect this may have during the year on the Group's cash position and working capital requirements, the Board is of the opinion that it would be imprudent to make a resolution already at the annual general meeting on 19 May 2016 to pay dividends on the company's preference shares when the record dates for the dividend payments do not occur until October 2016 and April 2017.

In consideration of the foregoing, the Board proposes that for the time being no dividends be paid on the company's preference shares. If the Board later concludes that a payment of dividends on the preference shares will be possible, the Board will convene an extraordinary general meeting in the beginning of October 2016 and/or April 2017 where a resolution can be made to pay dividends on the preference shares.

The Board further proposes that no dividends be paid on ordinary shares.
